APPROPRIATION ORDINANCE NO. 2020-02

AN ORDINANCE APPROVING GENERAL FUND SUPPLEMENTAL BUDGET NO. 02 FOR FISCAL YEAR 2020 OF ALBUERA, LEYTE WITH A TOTAL AMOUNT OF FOURTEEN MILLION EIGHT HUNDRED SIXTY-SIX THOUSAND SEVEN HUNDRED SIXTY-THREE PESOS (PHP 14,866,763.00) ONLY

WHEREAS, DBM – Local Budget Circular No. 125, dated April 17, 2020 provides that “for easy monitoring/tracking of the utilization of the allocation of each city and municipality, a Special Account in the General Fund (SAGF) for the Bayanihan Grant to Cities and Municipalities (BGCM) shall be created through an Ordinance by the Local Sanggunian pursuant to Section 313 of RA 7160;

WHEREAS, the same DBM – Local Budget Circular states that the creation of a Special Account in the General Fund (SAGF) for the Bayanihan Grant to Cities and Municipalities (BGCM) may also be done by the Local Sanggunian through inclusion in a pertinent Appropriation Ordinance authorizing a Supplemental Budget covering the BGCM;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Special Session that:

Section 1. General Fund Supplemental Budget No. 02 for Fiscal Year 2020 of Albuera, Leyte with a total amount of Fourteen Million Eight Hundred Sixty-Six Thousand Seven Hundred Sixty-Three Pesos (Php 14,866,763.00) for consideration, for purposes specified in the accompanying schedules, is hereby approved;

Section 2. This Ordinance shall take effect immediately upon approval hereof;

Section 3. The Provincial Budget Officer, Tacloban City, shall be furnished copies of this ordinance thru the Municipal Budget Officer, Albuera, Leyte, for review.


