**AN ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS IN THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE, IN THE AMOUNT OF SIXTY-TWO THOUSAND ONE HUNDRED SEVENTY-FIVE PESOS & 57/100 (PHP. 62,175.57) ONLY**

**BE IT ORDAINED**, by the Sangguniang Bayan of Albura, Leyte in Regular Session that:

**Section 1. Use of Savings & Augmentation.** – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, this august body is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

**Section 2. Priority in the use of Personal Services Savings.** – The request from the **Municipal Planning and Development Office of Albura, Leyte** for augmentation of appropriation in the amount of **Sixty-Two Thousand One Hundred Seventy-Five Pesos & 57/100 (Php. 62,175.57) only** is hereby approved.


