APPROPRIATION ORDINANCE NO. 2020-03

AN ORDINANCE APPROVING GENERAL FUND SUPPLEMENTAL BUDGET NO. 03 FOR FISCAL YEAR 2020 OF ALBUERA, LEYTE WITH A TOTAL AMOUNT OF FORTY-SEVEN MILLION NINE HUNDRED NINETY-THREE THOUSAND FOUR HUNDRED NINETEEN PESOS & 27/100 (PHP47,993,419.27) ONLY.

BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

Section 1. General Fund Supplemental Budget No. 03 FY 2020 of the Municipality of Albuera, Leyte involving a total amount of Forty Seven Thousand Nine Hundred Ninety Three Pesos & 27/100 (Php47,993,419.27) for consideration, for purposes specified in the accompanying schedules, is hereby approved;

Section 2. The Provincial Budget Officer, Tacloban City, shall be furnished copies of this ordinance thru the Municipal Budget Officer, Albuera, Leyte, for review.

Section 3. Separability Clause. – If, for any reasons, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions of thereof which are not affected thereby shall continue to be in full force & effect.

Section 4. Effectivity – The provisions of this Ordinance shall take effect immediately upon approval.


