BE IT ORDAINED, by the Sangguniang Bayan of Albura, Leyte in Regular Session that:

Section 1. Use of Savings & Augmentation. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, this august body is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

Section 2. Priority in the use of Personal Services Savings. – The request from the **Office of the Municipal Mayor of Albura, Leyte** for augmentation of appropriation in the amount of **Eight Thousand One Hundred Ninety-Seven Pesos & 36/100 (Php. 8,197.36) only** is hereby approved.
