ORDINANCE NO. 2020-02

AN ORDINANCE AUTHORIZING THE AUGMENTATION OF FUNDING ALLOCATIONS OF PROGRAMS, PROJECTS, AND ACTIVITIES PRIORITIZED IN THE CY 2020 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) ANNUAL INVESTMENT PLAN IN THE AMOUNT OF ONE MILLION ONE HUNDRED THOUSAND PESOS (PHP 1,100,000.00) ONLY

BE IT ORDAINED, by the Sangguniang Bayan of Albura, Leyte in Regular Session that:

Section 1. Use of Savings & Augmentation. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, this august body is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

Section 2. Priority in the use of Personal Services Savings. – The request from the **Municipal Disaster Risk Reduction Council (MDRRMC)** for augmentation of appropriation in the amount of **One Million One Hundred Thousand Pesos (Php. 1,100,000.00) only**, is hereby approved.
