ORDINANCE NO. 2020-06

AN ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS IN THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE OF ALBUERA, LEYTE AMOUNTING TO NINETEEN THOUSAND ONE HUNDRED SIXTY-EIGHT PESOS & 04/100 (PHP. 19,168.04) ONLY

BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

Section 1. Use of Savings & Augmentation. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, this august body is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

Section 2. Priority in the use of Personal Services Savings. – The request from the **Municipal Environment and Natural Resources Office of Albuera, Leyte** for augmentation of appropriation in the amount of **Nineteen Thousand One Hundred Sixty-Eight Pesos & 04/100 (Php. 19,168.04) only** is hereby approved.


Section 4. Effectivity – The provision of this Ordinance shall take effect immediately upon approval.
