### **Executive Order**

No. 3, Series of 2020

#### **AN ORDER PLACING THE MUNICIPALITY OF ALBUERA IN GENERAL COMMUNITY QUARANTINE AND ENHANCING THE IMPLEMENTATION OF MANDATORY PRECAUTIONARY MEASURES AGAINST COVID-19**

**WHEREAS**, the President of the Republic of the Philippines thru Proclamation No. 922 declaring the entire country under a State of Public Health Emergency, Proclamation No. 929 placing the entire country under the State of Calamity and the Provincial Governor of Leyte thru Executive Order No. 03-2020-03 series of 2020 placing the entire Province of Leyte under General Community Quarantine due to the Corona Virus Disease 2019 (COVID-2019);

**WHEREAS**, due to the Situation Report of Corona Virus Disease 2019 (COVID-19) fast transmission and increasing number of infected individuals in the country, there is a need to streamline all measures relative to the prevention and containing of COVID 19 virus;

**NOW, THEREFORE, I, SIXTO B. DELA VICTORIA**, Municipal Mayor of the Municipality of Albuera, Leyte, by virtue of the powers vested in me by law, in the interest of public health and safety, do hereby order the following:

1. **Declaration of General Community Quarantine.** It is hereby declared that the Municipality of Albuera is under General Community Quarantine;
  - a. The General Community Quarantine Period as provided for in this E.O. shall start at 12:00 o'clock midnight of March 20, 2020 until April 20, 2020;
  - b. Said period may be shortened or extended depending on the recommendation of the Municipal Novel Corona Virus 2019 Task Force.
2. All residents are highly enjoined to observed the following measures:
  - a. Regular hand washing
  - b. Social distancing of 1 meter radius apart from each other
  - c. Suspension of mass gatherings
  - d. Staying at home
  - e. Disinfection of homes and common places
  - f. Voluntary home quarantine for Persons under Monitoring (PUM) and Persons under Investigation (PUI)
3. All barangay officials are directed to strictly impose necessary measures to ensure the safety of its constituents including, but not limited to, information campaign on Covid-19 and maintaining cleanliness in their respective barangays. Monitoring of PUM's and PUI's shall also be strictly observed in coordination with the Municipal Health Office.
4. **Curfew.** There shall be implemented a curfew hour to all residents from 9:00 o'clock in the evening until 4:00 o'clock in the morning of the following day.
5. **Restriction on travel.**
  - a. The entry of persons by land shall be prohibited except in the following instances:
    - i. Residents within the political jurisdiction of the Province of Leyte provided that proof of residency shall be presented upon entry;

- ii. Outside residents but who have work, business or self-employed within the political jurisdiction of the Province of Leyte provided that proof of employment and business registration shall be presented upon entry;
    - iii. Students should provided proof of enrollment upon entry
    - iv. Vehicles, including its driver and helpers bringing in goods, supplies, and equipment, provided documents shall be presented upon entry
    - v. Members of the PNP, Military and Health Personnel
  - b. The entry of persons by sea shall be prohibited except in the following instances
    - i. Trucks carrying goods and supplies provided that the driver and helper shall not be allowed entry to the Municipality. The goods or supplies delivered shall be picked up by other individuals already residing in the municipality;
    - ii. Members of the PNP, Military and Health Personnel
6. **CHECK-POINT.** Check-point will be established at the municipal border manned by the members of the Albuera PNP, the Armed Forces of the Philippines (AFP), the Municipal Health Office (MHO), the Municipal Disaster and Risk Reduction and Management Office (MDRRMO), the Bureau of Fire Protection, Barangay officials and from the Civic Organization Karacho.
7. **Closure of Business Establishments.** All business establishments except groceries and drugstores shall be closed by **9:00 o'clock in the evening until 5:00 o'clock in the morning** of the following day during the duration of the quarantine.
8. **Prohibition on Public Gatherings.** All public gatherings which draw a large number of people such as celebration of barangay fiestas and festivities, barangay assemblies, reunions, trade fairs, carnivals, cockfights, concerts, fund raising events, sports events and other public events shall not be allowed. Operation of recreational establishments like internet cafes, gaming shops, basketball courts, swimming pools, resorts, videoke, bars, billiard halls and the like shall be suspended.
9. **SELF-QUARANTINE FOR RETURNING INDIVIDUALS.** Returning individuals who recently arrived in the Municipality are directed to conduct self-quarantine for fourteen (14) days in their respective homes and to avail medical assistance immediately if symptoms of COVID-19 infection is suspected.
10. The Albuera Police Office and other law enforcement authorities are task to implement this EO and ensure that the same are properly observed. Any person who resist or seriously disobey our law enforcement authorities while in the performance of their duties may be prosecuted under Article 151 of the Revised Penal Code.
11. The private sector is strongly encouraged to enforce additional measures in its workplaces such as close monitoring of employees, flexible working time, thermal scanners, and provisions of alcohols or hand sanitizers at the entry/exit points of the establishments.

This Executive Order Shall take effect immediately and shall remain in force and effect until revoked or amended.
