Executive Order

No. 5. Series of 2020

AN ORDER EXTENDING THE PERIOD OF PLACING THE MUNICIPALITY OF ALBUERA IN GENERAL COMMUNITY QUARANTINE AND ENHANCING THE IMPLEMENTATION OF MANDATORY PRECAUTIONARY MEASURES AGAINST COVID-19

WHEREAS, the President of the Republic of the Philippines thru Proclamation No. 922 declaring the entire country under a State of Public Health Emergency and Proclamation No. 929 placing the entire country under the State of Calamity;

WHEREAS, the Provincial Governor of Leyte thru Executive Order No. 04-2020-01 series of 2020 extending the period of placing the entire Province of Leyte under General Community Quarantine due to the Corona Virus Disease 2019 (COVID-2019);

WHEREAS, on March 19, 2020 by virtue of E.O. No. 3, series of 2020, the entire Municipality of Albuera was placed under General Community Quarantine to expire on April 20, 2020;

WHEREAS, the Municipal Novel Corona Virus 2019 Task Force recommends for approval the extension of the General Community Quarantine of the municipality;

NOW, THEREFORE, I, SIXTO B. DELA VICTORIA, Municipal Mayor of the Municipality of Albuera, Leyte, by virtue of the powers vested in me by law, in the interest of public health and safety, do hereby order the following:

- Extension of the Declaration of General Community Quarantine. The declared General Community Quarantine of the Municipality of Albuera shall be extended and continue until 11:59 o'clock in the evening of April 30, 2020 and may be shortened or extended depending on the recommendation of the Municipal Novel Corona Virus 2019 Task Force.
- 2. General Provisions. The following measures is hereby ordered for all constituents:
 - a. Regular hand washing
 - b. Social distancing of 1 meter radius apart from each other
 - c. Staying at home
 - d. Disinfection of homes and common places
 - e. Wearing of Face Mask is mandatory in public places.
 - Liquor drinking session in public is strictly prohibited and Liquor Ban will be implemented.
 - g. Barangay officials are directed to strictly impose necessary measures to ensure that their respective barangay remains a COVID19 FREE COMMUNITY. Monitoring of PUM's and PUI's shall also be strictly observed in coordination with the Municipal Health Office.
 - h. All public gatherings which draw a large number of people shall not be allowed. Operation of recreational establishments like internet cafes, gaming shops, basketball courts, swimming pools, resorts, videoke, bars, billiard halls and the like shall be suspended.
 - The private sector is strongly encouraged to enforce additional measures in its workplaces such as close monitoring of employees, flexible working time, thermal scanners, and provisions of alcohols or hand sanitizers at the entry/exit points of the establishments.
- Curfew. There shall be implemented a curfew hour to all residents from 9:00 o'clock in the evening until 4:00 o'clock in the morning of the following day.
 - a. No person can come out from their residence, dwelling and its immediate surroundings except for employment, livelihood, those who will buy food or medicine, go to the hospital or in an emergency situation.
 - b. No minors, senior citizens, pregnant women, sick and immune compromised individuals can go out of their residence or dwelling except for medical purposes. Barangay officials shall assist the above-mentioned persons in securing their basic needs and will implement this provision with the assistance of the PNP and AFP. Government Officials and employees, medical practitioners and workers, frontline volunteers and the same are exempted on this ban.

- 4. Restrictions of Movement. The entry of all persons coming from places with confirmed local transmission of COVID-19 is strictly prohibited. Non residents of this municipality without any valid reasons including, but not limited to, passer bys, working, livelihood, medical and health reasons, purchase of necessary food and house supplies are also restricted. Residents of the municipality is not restricted, subject however to the compliance of the health and sanitary protocols issued by the DOH. THE UNHAMPERED MOVEMENT AND TRAVEL OF ALL CARGOS FOR FOOD AND ESSENTIALS GOODS WILL BE OBSERVED AT ALL TIMES.
 - a. The entry of persons by land shall be prohibited except in the following instances:
 - Residents within the political jurisdiction of the Province of Leyte provided that certification issued from LGU of being non-PUM/PUI, government issued ID and proof of residency shall be presented upon entry;
 - Outside residents but who have work, business or self-employed within the
 political jurisdiction of the Province of Leyte provided that certification issued
 from their respective LGU of being non-PUM/PUI, government issued ID proof
 of employment and business registration shall be presented upon entry;
 - Vehicles, including its driver and helpers bringing in goods, supplies, and equipment, provided documents shall be presented upon entry;
 - iv. Members of the PNP, Military and Health Personnel.
 - b. The entry of persons by sea shall be prohibited except in the following instances
 - Trucks carrying goods and supplies provided that the driver and helper shall not be allowed entry to the Municipality. The goods or supplies delivered shall be picked up by other individuals already residing in the municipality. NO PERSONAL CONTACT POLICY MUST BE OBSERVED AT ALL TIMES.
 - ii. Members of the PNP, Military and Health Personnel
- CHECK-POINT. Check-point will be established at the municipal border manned by the members of the Albuera PNP, the Armed Forces of the Philippines (AFP), the Municipal Health Office (MHO), the Municipal Disaster and Risk Reduction and Management Office (MDRRMO), the Bureau of Fire Protection, Barangay officials and from the Civic Organization Karancho.
- 6. Closure of Business Establishments. Pursuant to EO No. 4, series of 2020, all non-essential businesses and establishments shall be temporarily closed until further notice. All business establishments except the essential businesses and establishments shall be closed by 9:00 o'clock in the evening until 4:00 o'clock in the morning of the following day during the duration of the quarantine.
- 7. The Albuera Police Office and other law enforcement authorities are task to implement this EO and ensure that the same are properly observed. Any person who resist or seriously disobey our law enforcement authorities while in the performance of their duties may be prosecuted under Article 151 of the Revised Penal Code. VIOLATION OF THE SAME SHALL BE PENALIZED UNDER ANY APPLICABLE PROVISION THERETO.
- EFFECTIVITY. Previous executive orders or provisions thereof, which are inconsistent with
 this Executive Order, are deemed amended and superseded. This Executive Order shall be
 effective immediately, and shall remain in force and effect while the Public Health Emergency
 subsists, unless rendered ineffective in writing by the Mayor.
