MUNICIPAL ORDINANCE NO. 2020-07

AN ORDINANCE LIMITING THE MAXIMUM ALLOWABLE NUMBER OF PASSENGERS OF TRICYCLES WITHIN THE MUNICIPALITY OF ALBUERA, LEYTE TO A TOTAL OF THREE (3) PERSONS ONLY, AND ADOPTING THE TEMPORARY ADJUSTED FARE RATES THEREFOR DURING THE DURATION OF THE GENERAL COMMUNITY QUARANTINE DUE TO THE CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC

WHEREAS, there is a Presidential Proclamation No. 922 series of 2020 issued by President Rodrigo Roa Duterte declaring a State of Public Health Emergency throughout the Philippines due to COVID-19 which enjoins all government agencies and Local Government Units to render full assistance and cooperation in this time of health crisis;

WHEREAS, the Municipality of Albuera, Leyte has been placed under General Community Quarantine pursuant to Executive Order No. 4 and 5, which may be extended as the need arises;

WHEREAS, in its effort to help quell the spread of COVID-19 and to "flatten the curve", the Sangguniang Bayan of Albuera, Leyte passed Municipal Ordinance No. 2020-01, "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE MASKS AND STRINGENT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WITHIN ALBUERA, LEYTE DURING THE TERM OF THE GENERAL COMMUNITY QUARANTINE AND ANY EXTENSION THEREOF, AND PROVIDING PENALTIES FOR VIOLATIONS THERETO";

WHEREAS, pursuant to the spirit of the above-cited Ordinance, it behooves this august body to also limit the maximum allowable number of passengers of tricycles within the municipality of Albuera, Leyte, and to adopt the temporary adjusted fare rates therefor during the duration of the general community quarantine due to the coronavirus disease 2019 (covid-19) pandemic;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

Section 1. COVERAGE. All tricycle drivers and the riding public within the territorial jurisdiction of Albuera, Leyte are covered by this Ordinance;

Section 2. LIMITATION ON THE MAXIMUM ALLOWABLE NUMBER OF PASSENGERS FOR TRICYCLES AND THE PUTTING UP OF MAKESHIFT PLASTIC ACETATE TO ACT AS PROTECTIVE SHIELD AND DIVIDER. The maximum allowable number of passengers for every tricycle operating within the territorial jurisdiction of Albuera, Leyte during the duration of the General Community Quarantine due to the Coronavirus Disease 2019 (COVID-19) Pandemic is hereby limited to a total of three (3) persons only.

All tricycle drivers and operators are likewise mandated that a plastic acetate shall be installed inside their respective tricycles to act as a makeshift divider and protective shield for the riding public.

Section 3. TEMPORARY ADJUSTED SCHEDULE OF FARES

- a. The following shall be the uniform rate of fare for Tricycles for hire during the duration of the General Community Quarantine due to the Coronavirus Disease 2019 (COVID-19) Pandemic:

b. The foregoing table of fare shall be posted prominently in the tricycle for hire terminal and in a conspicuous part of the unit.

Section 4. PENALTIES. – Any driver/operator violating this ordinance shall be fined One Thousand Pesos (Php. 1,000.00) or an imprisonment of one (1) week or both fine and imprisonment at the discretion of the court.


Section 8. SEPARABILITY CLAUSE. – If, for any reasons, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions of thereof which are not affected thereby shall continue to be in full force & effect.

Section 9. EFFECTIVITY – The provisions of this Ordinance shall take effect immediately upon approval and shall remain effective during the period of the General Community Quarantine and until such time that the same is lifted.

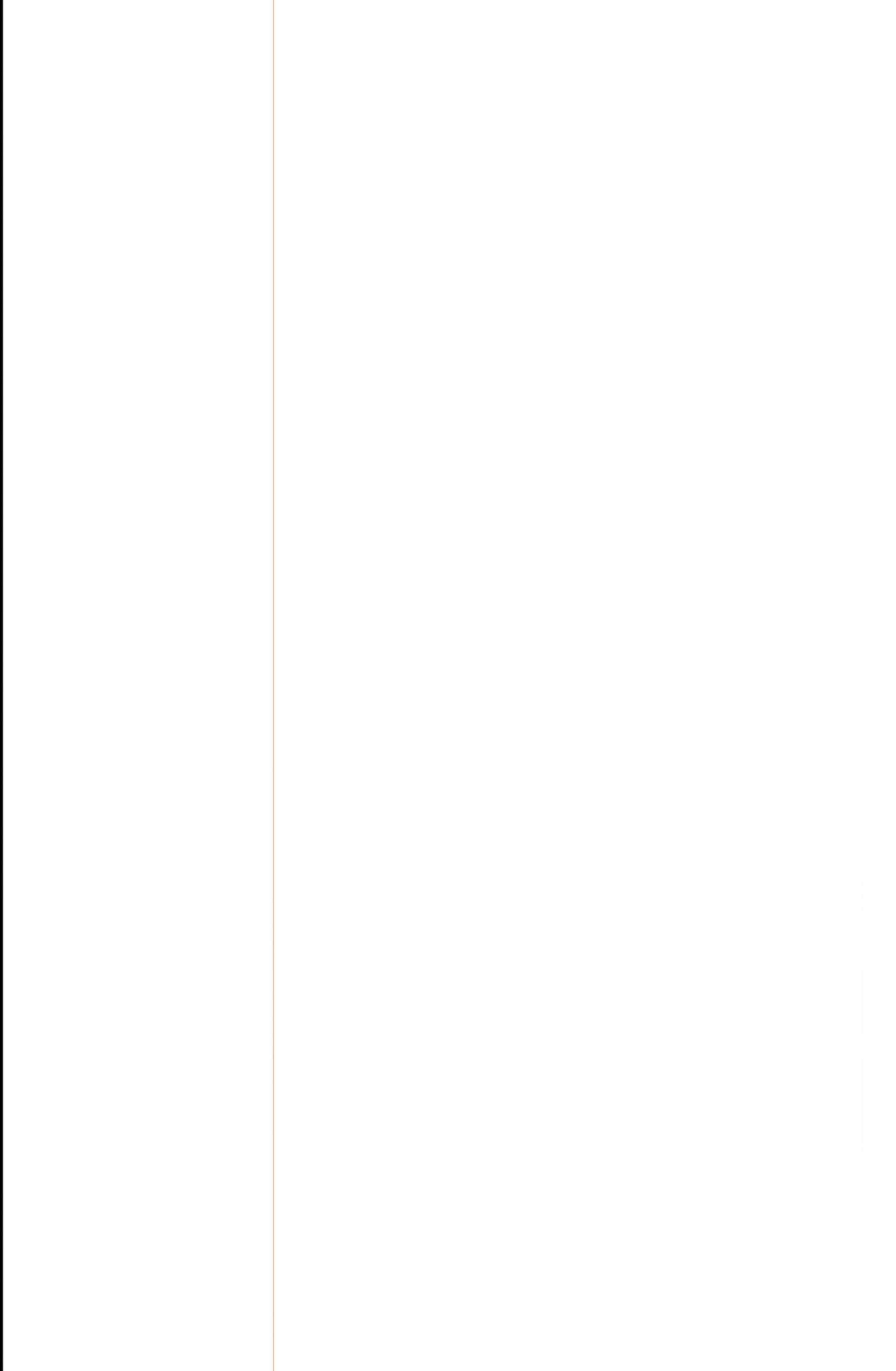
