AN ORDINANCE SUPPLEMENTING APPROPRIATION ORDINANCE NO. 11, SERIES OF 2019, "AN ORDINANCE APPROVING/AUTHORIZING GENERAL FUND ANNUAL BUDGET FOR FISCAL YEAR 2020 OF ALBUERA, LEYTE WITH A TOTAL AMOUNT OF TWO HUNDRED SIX MILLION THREE HUNDRED SEVENTY-NINE THOUSAND EIGHT HUNDRED FORTY-ONE PESOS (PHP 206,379,841.00) ONLY, COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF ALBUERA, LEYTE FOR FISCAL YEAR 2020, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE'

BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

Section 1. An Ordinance Supplementing "General Fund Annual Budget for Fiscal Year 2020 of Albuera, Leyte with a total amount of Two Hundred Six Million Three Hundred Seventy-Nine Thousand Eight Hundred Forty-One Pesos (Php 206,379,841.00) only", covering the various itemized expenditures for the operation of the Municipality of Albuera, Leyte, for purposes of reflecting therein the corresponding amount of subsidies made to the Economic Enterprises specified in the accompanying schedules attached herewith, is hereby approved and shall form part as an addendum to the General Fund Annual Budget for Fiscal Year 2020 of Albuera, Leyte, to wit: LBP Form No. 1, Annex C, BUDGET OF EXPENDITURES AND SOURCES OF FINANCING, LGU: ALBUERA, LEYTE GENERAL FUND - CONSOLIDATED; BUDGET OF EXPENDITURES AND SOURCES OF FINANCING, LGU: ALBUERA, LEYTE GENERAL FUND - PROPER; BUDGET OF EXPENDITURES AND SOURCES OF FINANCING, LGU: ALBUERA, LEYTE ECONOMIC ENTERPRISE -CONSOLIDATED; & BUDGET OF EXPENDITURES AND SOURCES OF FINANCING, LGU: ALBUERA, LEYTE ECONOMIC ENTERPRISE - WATERWORKS SYSTEM, MARKET OPERATIONS, & SIBUGAY MOUNTAIN RESORT

Section 2. If, for any reason, any Section or provision of this Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect;

Section 3. This Ordinance shall take effect immediately upon approval hereof;

Section 4. The Provincial Budget Officer, Tacloban City, shall be furnished copies of this ordinance thru the Municipal Budget Officer, Albuera, Leyte, for review.






