ORDINANCE NO. 2020-10

AN ORDINANCE MODIFYING THE POSITION ATTRIBUTES OF NURSING POSITIONS IN THE MUNICIPAL HEALTH OFFICE OF ALBUERA, LEYTE, FROM NURSE II SG 15 TO NURSE I SG 15, PURSUANT TO DBM BUDGET CIRCULAR NO. 2020-4, DATED JULY 17, 2020

INTRODUCED BY: HON. GERMANICO C. BARTE

WHEREAS, Section 32 of Republic Act (RA) No. 9173 or The Philippine Nursing Act of 2002 provides a minimum base pay of not lower than Salary Grade (SG)-15 for Nurses working in the public health institutions;

WHEREAS, the Supreme Court of the Philippines, in Ang NARS Party-List, et. al, vs. The Executive Secretary, et. al (G.R. No. 215746) upheld the validity of Section 32 of RA No. 9173. Said SC En Banc Decision has become final and executory on December 13, 2019;

WHEREAS, the Department of Budget and Management (DBM) issued Budget Circular No. 2020-4, dated July 17, 2020 to prescribe the rules and regulations on the upgrading of the entry-level of Nurse positions to SG-15, as well as to highlight the administrative procedures in view of the consequential modification in the position attributes of the Nurse items;

WHEREAS, the Human Resource Management Office of Albuera, Leyte sent a letter dated August 12, 2020 addressed to the Hon. Tita P. Alajas, Municipal Vice Mayor, Albuera, Leyte, respectfully requesting for the passage of an ordinance modifying the position attributes of Nursing Positions, as per DBM Budget Circular No. 2020-4, dated July 17, 2020;

WHEREAS, pursuant to the afore-cited provision of RA No. 9173 or The Philippine Nursing Act of 2002, the above-cited ruling of the Supreme Court, and DBM Budget Circular No. 2020-04, it is just and proper to modify the Position Attributes of the Nurse Positions in the Municipal Health Office of Albuera, Leyte, from Nurse II SG 15 to Nurse I SG 15;

WHEREFORE, BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session assembled that:

Section 1. Modification of the Position Attributes of the Nurse Positions. Pursuant to Item No. 8.1, the position attributes of the following classes of Nurse positions are hereby modified:

FROM	SALARY GRADE	TO	SALARY GRADE
Nurse II	15	Nurse I	15

Section 2. Separability Clause. – If, for any reasons, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions of thereof which are not affected thereby shall continue to be in full force & effect.

Section 3. Effectivity – The provision of this Ordinance shall take effect immediately upon approval.
