AN ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS IN THE OFFICE OF THE MUNICIPAL MAYOR OF ALBUERA, LEYTE AMOUNTING TO EIGHT THOUSAND ONE HUNDRED NINETY-SEVEN PESOS & 36/100 (PHP. 8,197.36) ONLY

BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

Use of Savings & Augmentation. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, this august body is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

Priority in the use of Personal Services Savings. - The Section 2. request from the Office of the Municipal Mayor of Albuera, Leyte for augmentation of appropriation in the amount of Eight Thousand One Hundred Ninety-Seven Pesos & 36/100 (Php. 8,197.36) only is hereby approved.
